

CALIFORNIA KIWIFRUIT REPORT DESCRIPTIONS AND DUE DATES

Shipment Report - Monthly shipment by destination report, including all shipments made the previous month. **Monthly Shipment Report totals should match monthly KISS Shipment totals.**

Due by 1:00 p.m. on the 5th of each month. (If the 5th falls on a weekend/holiday the due date is the next work day.)

KISS Add Inventory – First report includes all fruit packed (beginning inventory) through October 31st. Subsequent reports are used to add inventory to initial beginning inventory. Inventory additions may be a result of fruit harvested and packed after Oct. 31st, fruit packed from bins in storage, previously reported fruit repacked into a different container style.

KISS Shipments – Used to report shipments by size and container style. Shipments are deducted from reported inventory to provide a current inventory report. **Monthly KISS Shipment totals should match monthly Shipment Report totals.**

KISS Deduct Inventory – Used to report deductions in previously reported inventory for reasons other than shipments. (Fruit repacked into a different container style, loss to repack, etc.)

Due by 1:00 p.m. on the 5th of each month, **beginning November 5th**. During the months of December, January & February a mid month report is due by 1:00 p.m. on the 20th to report inventory changes/shipments from the 1st to the 15th of the month. During these 3 months the report due on the 5th covers inventory changes/shipments from the 16th through the end of the month. (If the 5th or 20th falls on a weekend/holiday the due date is the next work day.)

KISS Price/Shipment Report - Includes data on gross f.o.b. sales and the total number of containers shipped by pack, fruit size, grade, and market destination. Handlers submitting the KISS Price/Shipment report will no longer be required to submit the existing Shipment by Destination report or the KISS/Shipment report as that information will be collected on the new KISS Price/Shipment report. However, handlers submitting the KISS Price/Shipment report will still be responsible for filing the KISS/ Add Inventory and KISS/ Deduct Inventory reports.

The KISS Price/Shipment Report is due by 5:00 p.m. each Tuesday from the time your shipping season begins until it ends.

Year End Sales Report –Used to report annual Gross FOB sales by container style and size.

Due 30 days from the date of final shipment for season, or, July 1st, whichever is earlier.

Final Packout Report – Annual report used to report individual grower production/acreage information.

Due 30 days from the date of final shipment for season, or, July 1st, whichever is earlier.

Return Receipt of Kiwifruit to Grower – Used to serve as proof of fruit ownership when transporting/selling fruit.

Due within 5 days from when grower picks up fruit from packers or storage.
